Discussion with the Cabinet Secretary included matters such as workforce planning, apprenticeships and bursaries. We were pleased that the Cabinet Secretary agreed to visit a multi-disciplinary team, working in Deeside.

Launch of AHPF Cymru manifesto

As we look ahead to the Senedd elections in May 2026, AHPF Cymru launched a manifesto this spring and have started actively engaging with the political parties. Meetings have been organised with the Members of the Senedd working on writing the manifestos for their respective political parties and representatives of AHPF Cymru will be at all party-political conferences this year to spread the word on our key asks. AHPF Cymru has identified five key areas of focus that we believe political parties must prioritise to ensure the future sustainability and effectiveness of AHPs across Wales. The five key areas are:

- 1.A National Workforce Strategy for AHPs.
- 2.Timely access to AHP services for those working in health and social care.
- 3.Expand access to the AHP professions through exploring routes, in consultation with the professions, such as degree apprenticeships.
- 4.Ensure that services within the community are delivered within suitable buildings.
- 5.Allow patients the right to access AHP services as part of their treatment pathway.

In attendance was cross-party representation of Members of the Senedd and the keynote speech was delivered by the Minister for Children and Social Care, Dawn Bowden MS. Most importantly, it was an opportunity for our members to engage in discussions with stakeholders about their strategic priorities.

More Senedd engagement

AHPF Cymru has also taken the opportunity to engage with the Senedd by submitting written evidence to relevant consultations by two Committees. AHPF Cymru responded to the Economy, Trade and Rural Affairs Committee's Consultation on Apprenticeship Pathways and to the Health and Social Care Committee's consultation on the future of general practice in Wales. We look forward to continued engagement with Senedd committees in the future and hope for the opportunity soon to provide oral evidence.

Mae cyfarfodydd wedi cael eu trefnu gydag Aelodau'r Senedd sydd yn gweithio ar ysgrifennu'r maniffesto ar gyfer eu priod bleidau gwleidyddol a bydd cynrychiolwyr AHPF Cymru ym mhob cynhadledd wleidyddol eleni i ledaenu'r gair am ein prif ofynion. 5. Caniatáu i gleifion gael mynediad at wasanaethau AHP fel rhan o'u llwybr triniaeth.
